## **Updated Historic Preservation Ordinance**

## The City of Littleton

is in the process of updating its historic preservation ordinance. We asked Rick Cronenberger, a member of Historic Littleton Inc. and the Vice-chairman of the Historic Preservation Board, to explain the new ordinance and the background of the Historic Preservation Board. Historic Littleton Inc. urges its members to read the new ordinance and show your support when this comes before the Littleton City Council in April.

In 1971, the Littleton City Council recognized that Littleton had historic structures that had "Architectural or Historical Significance as LANDMARKS" and needed to be recognized and designated. The council at that time instructed the Littleton Historical Museum to oversee the survey, identification and designation of Littleton's historic structures. Littleton was leading the way for historic preservation in Colorado by passing this ordinance, only 5 years after the 1966 National Historic Preservation Act was passed by the U.S. Congress.

In 1979, the City Council adopted the "Littleton Historic Preservation Code." This ordinance has not been modified since that time. However, the world of historic preservation has evolved substantially.

The Museum Board oversaw all activities related to historic preservation from 1979 - 1997. Under the Museum Board, several significant properties were designated "Landmarks." In 1995 the City of Littleton was designated a "Certified Local Government (CLG)," by the Colorado State Historical Society. Under this designation, the State of Colorado delegated certain preservation actions to the local board. It also required that some members of the board be familiar with historic preservation regulations.

To meet these requirements the City Council created the Historic Preservation Board in 1997 for the "purposes of designating and preserving structures and areas important to the City's cultural, historic and architectural heritage." The Council then instructed the Historic Preservation Board (HPB) to rewrite the existing ordinance to bring it up to current standards and requirements for historic preservation. The board has devoted the last 3 ½ years to this effort, and the revised ordinance is ready for public hearing and adoption by the Council.

So, what changes are proposed for the new ordinance? All the sections of the current ordinance were kept, though the language was updated in many places. Several sections were added to provide additional checks and balances for property owners and the City. For example, the new ordinance includes information regarding economic hardship, reviewing the possible demolition or relocation of a historic landmark, unsafe or dangerous conditions, and special duties, maintenance and obligations for the owners of historic properties.

There is a non-consensual designation section in the new ordinance. This is a common feature in most local preservation ordinances and allows the city to designate a property a landmark if it is in the best interest of the city. It would be used in cases where an exceptionally significant historic property was threatened to be destroyed. It could also be used to create a historic landmark district when a majority of property owners were in favor of this.

The section of Economic Incentives for Historic Properties was expanded. The current ordinance only offers a rebate of the Littleton City property taxes. New incentives may include a rebate of building permit fees, rebate on the sales tax on material used for maintenance or restoration work, and possible low interest loans. Additional incentives include federal and state income tax credits for qualified

preservation work, grant money and City or grant funded assistance from a historical architect.

Finally, with the revised ordinance the Historic Preservation Board will be located under the Community Development Department and work closely with the planning commission, building code department and economic development.

The board has worked very hard to write an ordinance that will serve the citizens of Littleton well. The historic preservation site is still under construction. Eventually it will contain a significant amount of information on historic preservation issues.
