## Walking in Pioneers' Footsteps

When Littleton's Director of Public Services Charlie Blosten talks about putting a 1.7 mile walking trail along the historic City Ditch, his enthusiasm is catching.

"This is probably the most exciting, fun project I've worked on in 41 years," Blosten says. "The key thing is when you walk along this trail you are walking in the footsteps of the pioneers."

Pioneers like Richard S. Little, who came here in 1861 to survey the City Ditch, after the first surveyor failed at the job. Little liked this area so much that he brought his wife Angeline here, homesteaded 120 acres, and eventually established the town of Littleton.

Blosten recently came to a Historic Littleton Inc. board meeting to ask for support for the trail project, which was enthusiastically given.

Blosten has assembled over \$1 million in funding to construct the trail, which will connect the Lee Gulch Trail to the Big Dry Creek Trail. Construction of the first phase, from Littleton Boulevard north, will hopefully begin this year.

Future plans include adding amenities such as benches, trees and historical signage.

The trail will connect historic sites such as the Littleton cemetery, downtown, the courthouse, and the Depot Art Center.

"Part of my goal is to encourage the City of Englewood, who manages the ditch, not to pipe the entire length, because of its historic value," Blosten said.

Awards will be presented for outstanding historic preservation projects, stewardship, and advocacy. A nomination form is included with this newsletter. Nominations are due April 1.
